- <sup>i</sup> **Ministry of Education Requirements for registration under Phase 2B**  
For a child whose parent has joined the school as a parent volunteer not later than 1 July of the previous year and has given at least 40 hours of voluntary service to the school by 30 June of the current year; or whose parent is a member of the church/clan directly connected with the school; or whose parent is endorsed as an active community leader.
- <sup>ii</sup> **For the application to be supported, at least one parent should have received a positive response (YES) for three (3) out of the four queries listed above, concerning the active membership of the child's parents (positive responses for the first two being required and non-negotiable).**
